7321. Mr A D Beesley (ActionSA) to ask the Acting Minister of Police:

With reference to Programme 5: Protection and Security Services in the 2025 Estimates of National Expenditure, what is the disaggregated (a) actual expenditure in the 2024-25, (b) current expenditure in the 2025-26 and (c) projected expenditure in the 2026-27 financial years on VIP and/or Static Protection Services for the (i) President, (ii) Deputy President, (iii) Ministers, (iv) Deputy Ministers, (v) international dignitaries, delegations and (vi) any other category of person and/or office-bearer receiving VIP protection from the SA Police Service;

REPLY:

(a) Actual expenditure in 2024/25 for both the Protection and Security Services (PSS) and Presidential protection Services (PPS) capabilities, is indicated below:

- VIP Protection: R2 291 016 billion:
 - PSS VIP: R 1 214 238 billion.
 - PPS VIP: R 1 076 778 billion.
- Static protection: R1 417 816 billion:
 - PSS Static: R 1 297 302 billion.
 - PPS Static: R 85 069 million.
 - KwaZulu-Natal Static (Traditional Leaders): R 35 445 million.

(b) Current expenditure for 2025/26, as at 30 November 2025, is indicated below:

- VIP Protection: R1 519 461 billion:
 - PSS VIP: R 790 120 million.
 - PPS VIP: R 729 341 million.
- Static Protection: R 971 759 million:

- PSS Static: R 883 329 million.
- PPS Static: R 64 136 million.
- KwaZulu-Natal Static (Traditional Leaders): R 24 294 million.

(c) Projected expenditure for 2026/27 is indicated below:

- VIP Protection: R2 460 351 billion
- Static protection: R1 600 562 billion

With regards to (i) to (vi): It is not possible to split the expenditure per VIP as requested, the expenditure is categorised per objective (VIP and STATIC Protection). Further more, resources are shared amongst VIP's that makes it impossible to split.

However, the following expenditure is projected in the 2026/27 financial year for:

- Protection and Security Services:
 - PSS (Ministers, Deputy Ministers, international dignitaries, delegations and any other category of person and/or office-bearer receiving VIP protection)
 - VIP Protection is projected at approximately R 1 279 383 billion.
 - Static Protection is projected at approximately R 1 456 511 billion.
- Presidential Protection Service:
 - PPS (President, Deputy President, international dignitaries, delegations and any other category of person and/or office-bearer receiving VIP protection)
 - VIP Protection is projected at approximately R 1 180 968 billion.
 - Static Protection is projected at approximately R 96 034 million.
- KwaZulu-Natal Provincial Office:
 - KwaZulu-Natal Provincial office STATIC Protection for Traditional Leaders (Kingship) is projected at approximately R 48 017 million.
